LOS VAQUEROS DE LAS MONTANAS PARTICIPANT'S AGREEMENT

In consideration of Los Vaqueros de Las Montanas, it's members, employees, volunteers, officers, directors, agents and affiliates (hereinafter "Los Vaqueros"), allowing ("Participant") to participate in any equestrian event such as, but not limited to, horse shows, rodeos, clinics, trail rides, equestrian contests, play days, dances, overnight camping, meetings, etc., which are sponsored, promoted or operated or in any way affiliated with Los Vaqueros activities, it is agreed on behalf of Participant and for his/her heirs, assigns and representatives, (hereinafter collectively "Participant") that:

I, (please print your name) _____, for myself, my representatives, heirs and assigns hereby **FOREVER RELEASE AND DISCHARGE** Los Vaqueros from any and all liabilities, claims demands or causes of action that I may hereafter have for any injuries or damages arising out of my participation in and use of Los Vaqueros' premises whether arising out of or incidental to any activities, including but not limited to losses **CAUSED BY THE NEGLIGENCE OF** Los Vaqueros, or by hidden, latent, or obvious defects on the premises and/or any equipment used.

I understand and acknowledge that all equestrian activities, whether directly or indirectly involved, have inherent dangers that no amount of care, caution, instruction or expertise can eliminate. **I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH, PERSONAL INJURY OR PROPERTY DAMAGE SUSTAINED WHILE PARTICIPATING IN EQUESTRIAN OR EQUESTRIAN RELATED ACTIVITIES OF ANY TYPE**, including but not limited to variations or changes in surface, lighting or weather conditions, or by hidden, latent, or obvious defects on the premises or in the equipment used. I also recognize that other participants and spectators pose a danger to me and **I VOLUNTARILY ACCEPT ALL RISKS** connected with or arising from my participation in any such equestrian activities, whether or not incidental to my participation in these equestrian activities, and whether from known or unknown causes.

I HAVE DETERMINED that any equipment I use for the activities is adequate and appropriate for use. I also understand and accept that Los Vaqueros will not make any evaluation nor determination of my abilities nor of the appropriateness of any portion of my equipment.

As an **EXPRESS CONDITION** of being permitted to participate in these activities, I represent that I have observed activities of the type I now seek to participate in and have had the opportunity to inspect the premises, lighting or lack thereof and weather conditions. Whether or not I have exercised the foregoing opportunity, I further understand and accept that each of the foregoing conditions, as well as the participants and spectators pose a danger to me. I know, fully appreciate, and understand the scope, nature and extent of the risks involved in these activities. **I VOLUNTARILY AND FREELY CHOOSE TO INCUR ALL RISKS AND DANGERS.**

As a further express condition of being permitted to participate in these activities, I agree, for myself and for my heirs, assigns and representatives not to sue Los Vaqueros, and not to initiate or assist the prosecution of any claim for damages or cause of action which I or my heirs, assigns or representatives may have by reason of my suffering any personal injury, death or damage or destruction to my property arising from the activities contemplated by this agreement.

I agree for myself and my heirs, representatives and assigns to **INDEMNIFY AND HOLD HARMLESS** Los Vaqueros from any and all losses, claims, actions, causes of action, or proceedings of any kind which may be initiated by myself or by any other person or organization, including demands for damages, judgments, costs, loss of services, or expenses, arising

from the activities contemplated by this agreement, including but not limited to reasonable attorney fees incurred by Los Vaqueros herein.
